Course Booking Terms and Conditions as of June 2011

Please read these General Terms and Conditions of Enrolment in full before enrolling on your course/workshop, as they apply to all bookings and are deemed incorporated into your contract. They do not affect your statutory rights. If you book your course by phone you will be asked if you have read these T and Cs and agree to them. If you have any questions regarding these terms, please contact the office on 01257 411352.

By making a booking you confirm that you have accessed our website, and/or talked with one of our tutors, to decide which course or workshop is best for your needs. While we will do all that we can to help you make the right choice, the ultimate decision is yours and yours alone.

Level 2 and Level 3 course fees include:

Awarding Body registration fees.

All home study materials and 1st class Royal mail posting of.

Tutor support throughout the home study and assessment period.

Tuition and feedback on attendance days.

Assessment, verification and certification for passed units.

Course booking policy (Level 2 or 3 courses)

Booking an assessment code is like booking a holiday: once a place is sold to one person, it becomes unavailable to others. If during your home-study period you decide to change your choice of assessment code for whatever reason, you will need to pay an assessment code transfer fee. If you decide to change your assessment code and give at least 2 weeks notice from your practice assessment day, there will be a transfer fee of just £120 to provide you with another assessment code. We will not accept any transfer with less than 2 weeks prior to the practice assessment day unless this is due to medical reasons. In this situation you must provide the office with a medical certificate within 14 days and pay the fee for another assessment code, currently £120. Only 1 assessment transfer is permitted.

If you make the decision, at any stage of your course, not to attend the practice or actual assessment day no refund will be given.

You must attend the practice assessment day in order to attend the final assessment day.

All assessments and if required, resit must take place within 12 months of enrolling.

Venue and assessment date changes made by Bodylogic

In the unlikely event that Bodylogic has to change a practice and/or final assessment day including but not limited to where course numbers are below the recommended class size, a tutor is ill or a venue becomes unexpectedly unavailable, Bodylogic will offer you a choice of alternative dates. If these dates are not suitable for you and you choose to withdraw Bodylogic will provide a refund of £60 per changed date.

Bodylogic will also pay any reasonable travel and accommodation expenses you have necessarily incurred on the production of receipts if the assessment date change is within 48 hours of the planned assessment day. This is limited to economy class rail travel, fuel at the rate of 25p per mile from your residential address to the location and £50 in respect of hotel accommodation.

Venue Changes We reserve the right to change the assessment/workshop venue. Should this happen we guarantee that the new venue will be within 5 miles of the booked venue. Bodylogic will not be liable for any costs this may incur.

Failed units and re-sits. Bodylogic Training does not guarantee that you will pass a course/unit or that successfully completing a course/unit will provide you with anything other than the qualification granted under that course/module. If you do not pass a course/unit Bodylogic have no mandatory obligation to offer you a resit. However if a re-sit is offered you must attend the date we offer and pay the fee required.

Current fees are £40 for a theory test. £25 for resubmission of coursework and £60 for a practical assessment.

These fees are subject to reasonable change and you will be informed of this at the time of resit.

Course content and delivery. Course content/assessment delivery may change without notification subject to Awarding Body syllabus and certification changes.

Workshops. Once booked, no refunds or transfers can be offered. If we have to cancel a workshop a full refund will be offered or you may choose to book another workshop or date. Bodylogic will not be responsible for any other costs incurred providing we give you 24 hours notice.

Standing Order / Monthly payment agreement. If a payment is declined/not received without prior notification Bodylogic will pursue the full amount outstanding to the value of your booked course and also any incurred legal costs we may incur as a result of this action. You will also be withdrawn from any outstanding assessment dates until this full payment has been received. All outstanding fees must be paid before an OCR certificate is forwarded to you.
